Rules and Regulations

- 1. BOOTH SPACE:** Upon approval of your application and payment booth assignments will be made in order received. The location of your booth is completely at the discretion of the Car Show management.
- 2. APPROVED ITEMS:** The car show committee will approve all items to be sold or exhibited. Any variation from the approved items may result in immediate closure of your booth space with no refund. No sales of water toys, fire-works, poppers or explosive items of any kind are permitted.
- 3. SECURITY:** The San Dimas Sheriff's Booster Club and the City of San Dimas will not be liable for damage to, loss or theft of property of any exhibitor, vendor, agent, employees, visitors or guests. Each food vendor shall carry their own insurance. Vendors further agree that they have sole care, custody and control of any products or materials displayed or sold within the vendor's booth.
- 4. REGULATIONS:** All food booths must have an approved fire extinguisher. All canopies must be securely weighted down to prevent tipping/falling over, insuring public safety. (No stakes can be driven into any surface).
- 5. HEALTH PERMITS:** Food booths are required to have Los Angeles County Health Permits. Food vendors must abide by all health department rules and regulations.
- 6. INSURANCE:** Food Vendor's are required to carry \$1,000,00.00 insurance naming the City of San Dimas and San Dimas Sheriff's Booster Car Show, its employees, volunteers, or anyone working the event under the direction of the San Dimas Sheriff's Booster Club as co-insured. A copy must be provided before you can begin set up.
- 7. SET UP:** Setting up of booths may start at 5:00 a.m. the day of the event and must be in complete readiness, including removal of vehicles, for inspection by Car Show Management by 8:00 a.m.
- 8. CLEAN-UP AND REMOVAL OF BOOTHS:** No booth may be dismantled before the official closing time of the event (3:00 p.m.). Removal and clean-up must be completed within two hours of the official closing. All Vendors are responsible for keeping the area in and around their booths clean and free from trash during the event. All debris must be removed after the event.
- 9. ISSUES:** Issues not covered by these rules and regulations are subject to the decision of the San Dimas Sheriff's Booster Club, which shall have sole authority to interpret and enforce all rules and regulations.
